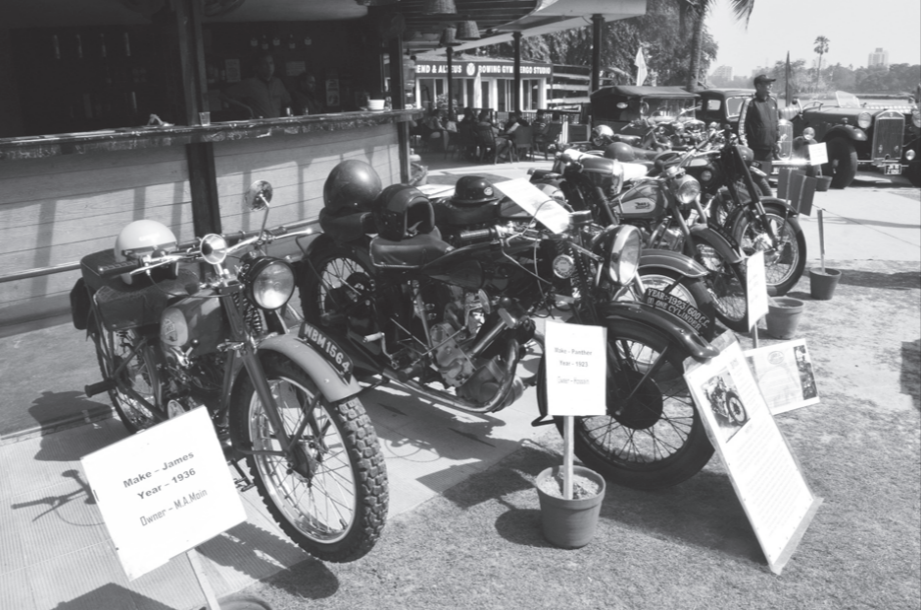

KOLKATA, FEB 13 /--/ Vintage car lovers of Kolkata were enthralled as they experienced a rare view of about ninety gentle jalopies lined up at the sprawling complex of the Lake Club near Rabindra Sarovar lake, in southern part of the city Sunday.

The exhibition, one of the most popular motoring events in Kolkata, has been jointly organised by Lake Club and Eastern India Motoring Group (EIMG). President of EMIG Srivardhan Ksnoria, who was the chief judge in this show, informed that around 90 best Heritage vehicles of Kolkata including nine vintage Rolls-Royces amongst other exotics were finally chosen for this show. The format for this event was as per the international standard, as regards to categorization and judging of the vehicles, Mr Kanoria said. The largest crowd puller in the show was the 1906 Renault owned by EIMG President Srivardhan Kanoria who also had three

Rolls Royces of 1923, 1925 and 1926 varieties and a 1931 Chevrolet, all of which, however, were kept only for display. The 'Best of Show' car turned out to be a 1937 Rolls Royces owned by Azam Monem for which he received the Momen Sahab Memorial Award.

Nine Motor Cycles also took part in the show out of which 1923 Panther, the oldest among the nine participating two wheelers and owned by Hossain, emerged best. Commenting on the event EIMG Secretary Subhajit Kumsr said this unique move of Lake Club getting together with EIMG has been a big step towards preserving the motoring heritage of eastern India.
